

# CCPA Privacy Notice

Effective January 1, 2020

<b>Why?</b>	<p>The California Consumer Privacy Act of 2018 (CCPA) gives California residents the right to know what Personal Information UroGen collects about them, including whether it is being sold or disclosed to third-parties, and the right to prevent UroGen from selling that information. The CCPA also prevents companies from retaliating against consumers for exercising these rights – companies must continue to give consumers who exercise the right to refuse sale of their Personal Information access to equal products for equal prices.</p> <p>All companies need to collect and share consumers’ Personal Information for everyday business purposes, marketing, and maintenance of the safety, security, and integrity of their websites and other assets, among other reasons. This notice provides the information required under the CCPA and applies to both UroGen’s online and offline activities. <b>What?</b>	<p>The types of Personal Information we collect, disclose, and/or sell depend on your relationship with UroGen. If the nature of your relationship with UroGen changes, a different data privacy notice may apply and will be provided to you.</p> <p>“Personal Information,” as used in this Notice, means any information that identifies, relates to, describes, or is capable of being associated with you or your household, whether directly or indirectly. <b>Your Rights</b>	<p>You have the following rights with respect to your personal information:</p> <ul style="list-style-type: none"><li>• The right to request access to the personal information that UroGen has about you, as well as the right to request rectification of any data that is inaccurate or incomplete.</li><li>• The right to request that we delete the personal information we have about you. We may not be required to delete information under particular circumstances.</li><li>• The right to be free from retaliation for exercising your rights. We may, however, offer you incentives in return for your data. When you exercise your rights, you may lose access to these incentives, which can include discounts, coupons, or additional services.</li></ul>
